The executive positions are: President, Vice-President Internal, Vice-President External, Vice-President Finance, Vice-President Academic Divisions 1 and 2, and Vice-President Academic Divisions 3 and 4.

REQUIRED: a minimum of twenty-five (25) graduate student nominators who are valid members of the Union, as defined in the Union's By-Law. Nominations are subject to verification. **Nominators must enter their full name, student number, initials/signature, phone number and UofT email address.**

Nominees are strongly encouraged to obtain more than the required minimum of nominators in the event that any

nomination is deemed invalid. If collecting nominator information by hand and emailing the CRO a scanned version, all sections must be written neatly by each nominator. Electronic submissions will also be accepted.

Accepted format: .pdf, doc. or docx (fill out the information below in this form)

OPTIONAL: Nominees may include a single statement of 800-words maximum in their application to be used by the UTGSU for the purpose of publicly declaring candidates. Submissions over 800 words will result in any and all extra words being deleted from the end of the statement. Candidates may also include one (1) link to their campaign webpage or social media at the end of their statement, which will not be included in the calculation of the 800 word maximum. The link will be published on UTGSU website, but will not be included on the voting platform. Edits or revisions will **not** be accepted once the form is submitted.
